Board decides to wait until 2022 to complete the work. John recommends June or July. Keith will confirm that the grant allows enough time to delay the work.

Blue Rock Project – Requested Construction certification from DEP.

Corbett Easement – Paving work has yet to be scheduled. EEMA is finalizing the panel upgrade and painting. Board agrees that they would like the project completed by September 15th and Keith will communicate that to the developer.
